

## TOLLING REGULATIONS INFORMATION SHEET

## Changes in Version 84 compared to Version 83

With this information sheet, we are giving an overview of the main changes to the Tolling Regulations in Version 84, compared to Version 83.

Version 84 of the Tolling Regulations will come into effect on 20<sup>th</sup> September 2025. You can find it at <u>asfinag.at/mautordnung/.</u>

### Adjustment of minimum and maximum amounts for GO-Box top-ups in Part B

In the Pre-Pay process, the minimum amount for the toll credit that must be loaded when picking up a GO-Box will be increased from EUR 75 to EUR 150, and the maximum amount per GO-Box will be increased from EUR 500 to EUR 750 (Part B, item 5.5.3 Pre-Pay process).

# Clarification regarding invalid payment methods for the digital section toll FLEX in Part A II

The digital section toll FLEX service will be blocked at the end of the day on which it is no longer possible to collect the section toll via the stored payment method for the first time. From this point on, the vehicle licence plate will no longer appear in the vignette registry (validity query) as registered for the digital section toll FLEX service for the duration of the block.

If the digital section toll FLEX service has been blocked for a vehicle licence plate, the digital section toll FLEX service can no longer be used for any other vehicle licence plates within an ASFINAG account for which the relevant payment method is stored. This is to prevent journeys from being made with other vehicle licence plates even though no debits can be made via the payment method in question (Part A II, item 4.2.2).

#### Appendix 4 supplemented with new toll sections

These toll sections will supplement the toll road network on the

S 7 Fürstenfelder expressway in the future:

Rudersdorf jct. – Königsdorf jct.
 Königsdorf jct. – Heiligenkreuz j jct.
 Heiligenkreuz jct. – Heiligenkreuz state border
 Section length: 9.456 km
 Section length: 1.760 km

Please note that the toll section "Rudersdorf jct. – Königsdorf jct." replaces the previous toll section "Rudersdorf jct. – Dobersdorf jct." as the temporary Dobersdorf junction is being closed.



### **Changes to Appendix 7**

## Additional minor changes in parts A I, A II, B and C, as well as in the Appendixes

A few minor clarifications have been made throughout the text of the Tolling Regulations:

- Cancellation of the "annual card" product
- Updating of section graphics and addition of the eastern section of the S 7
  Fürstenfelder expressway
- The payment methods and means have been updated in Appendix 2.
- Harmonisation of Appendix 2 and Part B with regard to the term "payment method" (Post-Pay/Pre-Pay)
- Minor textual adjustments were made to Appendixes 3e and 3f.
