#### 1 VIGNETTE LAYOUT

##### 1.1 Toll sticker

1.1.1 Annual toll sticker for motor vehicles with the maximum technically permissible laden mass of up to 3.5 t



1.1.2 Two-month toll sticker for motor vehicles with the maximum technically permissible laden mass of up to 3.5 t




1.1.3 Ten-day toll sticker for motor vehicles with the maximum technically permissible laden mass of up to 3.5 t



1.1.4 Security features triggered using the example of an annual toll sticker for vehicles up to 3.5 tonnes maximum technically permissible laden mass

Removing a toll sticker that has already been affixed triggers one or more of these security features and the vignette loses its validity (see Part AI, item 2.2.1).



## 1.2 Digital vignette for vehicles with the maximum technically permissible laden mass of up to 3.5 t



The digital vignette for motor vehicles with the maximum technically permissible laden mass of up to 3.5 t is available as a digital annual vignette, a digital two-month vignette, a digital ten-day vignette and a digital one-day vignette.

## 2 VIGNETTE PRICES

The vignette prices are set by law or by decree of the Federal Minister for Climate Protection, Environment, Energy, Mobility, Innovation and Technology in agreement with the Federal Minister of Finance. The vignette prices vary according to the type of motor vehicle and the duration of use; they include 20% value added tax (VAT).

The following prices were decreed by § 12 of the Federal Road Toll Act (BStMG) (BGBl I Nr. 307/2024):

The price of an **annual vignette** for

- single-track motor vehicles is **EUR 41.50** and
- for multi-track motor vehicles whose **maximum technically permissible laden mass** does not exceed 3.5 tonnes is **EUR 103.80**.

The price of a **two-month vignette** that entitles the holder to use the road network from 1 December 2024 or later for

- single-track motor vehicles is **EUR 12.40** and
- for multi-track motor vehicles whose **maximum technically permissible laden mass** does not exceed 3.5 tonnes is **EUR 31.10**.

The price of a **ten-day vignette** entitling the holder to use the road network from 1 December 2024 or later for

- single-track motor vehicles is **EUR 4.90** and
- for multi-track motor vehicles whose **maximum technically permissible laden mass** does not exceed 3.5 tonnes is **EUR 12.40**.

The price of a **one-day vignette**, entitling the holder to use the road network from 1 December 2024 or later for

- single-track motor vehicles is **EUR 3.70** and
- for multi-track motor vehicles whose **maximum technically permissible laden mass** does not exceed 3.5 tonnes is **EUR 9.30**.
